The Renter shall pay a security deposit of \$300 plus an \$80 rental fee for the 2 week rental term.

If an additional rental term is needed and equipment is available for that extended timeperiod, we will extend rental term for an additional 2 weeks at a cost of \$80.00. Add-on payment will be secured just prior to the first 2-week term's return date.

There is an additional shipping charge between \$16-\$65 depending on location in

country. We send package via USPS "Priority Mail - with Signature Confirmation and Insured for \$400."

A payment between \$412 to \$510 will be secured prior to equipment shipment or inperson retrieval.

The Owner (FilmFix) shall refund the \$300 deposit within 3 business days of Wolverine being returned in fine working order.

**Note**: Your return shipping cost back to us will range from \$16 to \$65 depending upon where you live – using USPS.

## The Return Shipment needs to meet these conditions:

- Use of a carrier which assigns a tracking number to package
- Package <u>requires recipient's signature</u> upon delivery
- Insure package for value of: \$400
- Renter (you) pay return shipping fee (Examples: Using same box as was sent and returning to us via USPS "Priority Mail, with Signature Confirmation and Insured for \$400" the cost from VA (Virginia) is \$56.45, from WA (Washington) is \$36.00 and from Paso Robles, CA \$16.10.)
- Renter sends Owner tracking number of package once return package is shipped. Send email to film@filmfix.com.

The equipment shall **only** be used in a proper and careful manner and shall not be used in a way which is inconsistent with the Owner's Manual. Owner's manual and itemized accounterments are included in box.

Equipment shall be kept in a safe state, not in direct sunlight, and covered to protect from dust and debris, when not in use. Note: Minimal wear and tear is expected.

If Equipment is not used by Renter, for any reason, or returned prior to 2 week time frame(s), no partial refund of the \$80 rental fee will be issued.

The Owner may terminate this Agreement immediately if the Renter fails to return the equipment when due. Additionally, Owner is not required to refund the \$300 deposit if time-line terms are not respected or if equipment is not returned when expected.

Renter indemnifies and holds Owner harmless for any injury or damage of any kind from their use of this Wolverine Equipment. Owner is not responsible for any possible damage to a Renter's film or materials due to use of the Wolverine Equipment.
